If you do not receive a scholarship the application fee will be returned to you or applied towards program or pass fees. A completed scholarship includes: Registration form, partial payment, 2008 Tax Returns and explanatory letter. The final step will be scheduling the volunteer hours needed.

- Financial need based on explanatory letter and 2010 tax returns. These will be kept confidential and destroyed after reviewing.
- Equipment awards are subject to availability.
- A love for skiing or snowboarding.
- *Special consideration is given to active participants in the organization and fundraising initiatives.*

Conditions of Scholarship Awards: All participants receiving a scholarship must abide by the following conditions. Failure to meet these requirements will result in the forfeiture of season pass.

- *All recipients will be required to write a letter of thanks to the Ski Gull Board of Directors.*
- Each recipient will meet with Ski Gull to schedule volunteer opportunities and sign agreement.
- Recipient must abide by the National Ski Association Responsibility Code.
- Disciplinary actions within Ski Gull may revoke scholarship award.

Only one scholarship application is required per family.
